#### **Board Voted**

Lourdes made a motion to appoint Darlene Dinan as Secretary and Linda seconded it and everyone was in favor of it.

# Taking Money from our Reserves for the payment of the roof

The insurance company sent a check for \$331,267.93 to pay for the roof. The previous board members Wanda and Silvia spent this money on unrelated items. We have to pay \$5,000.00 for our deductible on the insurance claim plus \$5000.00 for the painting of the rotten wood that had been replaced.

#### **Board Voted**

To avoid a Special Assessment Darlene Dinan made a motion to approve the withdrawal of \$341,267.93 from the Reserve Account to pay Power Roofing. Lourdes seconded it and everyone approved it.

Now we need it to go to the owners to vote In favor of it.

We require 75% of the owners to vote for the withdrawal of \$341,267.93 from our Reserves

Our Reserve account has a balance of \$602,170.75. This is for the replacement of the road, painting of the buildings, as well as other items. After the transaction, our balance will be \$260,902.82.

We will be hiring an attorney in the near future that is less expensive.

The board is taking on more responsibility from the management company to manage our condominium.

We have discussed with Associa to reduce our expenses by removing the extra personnel that we do not need. They are not willing to do that at this time since the previous board Siliva and Wanda had approved it and signed a contract for it.

Mila is not sending the owners June's payment to Associa. We are going over the accounts and will be getting that money applied to the owners' account.

We will be needing more volunteers to contact the owners to sign the removal of funds from the reserve to avoid a special assessment and so the roofer won't put a lien on our properties and sell it.
